- 2. Application for admission under Sports' Quota and Employees' Quota should be routed through the respective Head of Department and Departmental Admission Committee.
- 3. Spouse may be included under Employees' Quota besides children.
- 4. When the seat(s) reserved for candidates under a category is/are not filled, the same may be allotted to the ST candidate(s). However, due care should be taken to ensure that the eligibility of deserving candidates under various categories are accommodated before the seats are allotted to STs.
